**MEMORANDUM**

**Sub: Fixation of pension based on the notional pay in the notional scales of Rs.6500-200-10500 (5<sup>th</sup> CPC) in respect of those employees who retired as Insurance Inspector / Mgr. Gr-II/ Supdt. during the period between 21.04.2004 to 30.09.2007- reg.**  
**Ref.: ESIC Hqrs Office letter No.PF/B-11/14/1/05-E.III dated 07.05.2008.**

The ESI Corporation in its 172<sup>nd</sup> meeting held on 06.12.2017 has approved the fixation of pension based on the notional pay in the 5<sup>th</sup> CPC pay scales of Rs.6500-200-10500 in respect of those employees who retired as Insurance Inspector / Mgr. Gr-II/ Superintendent during the period between 21.04.2004 to 30.09.2007.

In accordance with the said approval and in supersession of the instructions contained in the letter under reference, all the Regional Directors are requested to initiate necessary action for fixation of pension / family pension based on the notional pay of the employees who retired as Insurance Inspector / Mgr. Gr-II/ Superintendent during the period between 21.04.2004 to 30.09.2007 in the 5<sup>th</sup> CPC pay scale of Rs.6500-200-10500.

It is however, again emphasized that monetary benefit on account of revision of pension/family pension, based on the notional pay will accrue only from 01.10.2007, and the same should be ensured and strictly complied with.

The revision of pension/family pension and payment of arrears on account of the above, should be completed within a period of sixty (60) days, and a comprehensive statement giving full details of the number of cases, names of pensioner/family pensioner, date of retirement, the pension fixed at the time of their retirement and the revised scales at which their pension has been fixed, should be furnished to this office, before 25.03.2018.
