For other category of persons with benchmark disabilities, the provision of scribe can be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government health care institution as per prescribed proforma appended at Annexure – G of the advertisement.

As such, PWD candidates other than in the category of **blindness, locomotor disability (both arm affected-BA) and cerebral palsy**, who have availed services of scribe in the Phase I and/or Phase II Exam for the post of **UDC** are required to submit certificate regarding physical limitation to write in the prescribed proforma appended at Annexure – G of the advertisement.
