IMPORTANT NOTE:

The candidates shortlisted for verification are required to submit**ORIGINAL** as well as 2 sets of <u>Self-Attested</u> copies of the following certificate/documents on the day of verification at the venue in support of their eligibility for the post as detailed hereunder:

- 1. Date of Birth/Matriculation or equivalent certificate in support of proof of Date of Birth,
- 2. Certificates/Mark Sheets etc. in support of Essential Educational/Technical/Professional Qualification for the post.
- 3. Registration Certificate with concerned council, wherever required.
- 4. Experience Certificate, wherever required.

- (SCT) dated 15.11.93 along with Self Declaration to be given at later stage as given at Annexure "B" failing which the benefit of reservation or age relaxation will not be given.
- 8. Candidates claiming reservation under EWS Category should submit the EWS Certificate given at Annexure -"C". Candidates claiming relaxation/reservation under Ex-servicemen Category should submit form of undertaking as given at Annexure -"D".
- 9. ESIC Employees/Government Quasi-government Servants shall have to produce No Objection Certificate (NOC) at the time of verification along with relieving order before joining the post.

- 15. Affidavit required in case of mismatch of the Name/Father's name/Surname etc., on various documents.
